#### h) Matters arising from the Reports of the Elected Officers

#### The Union President's report

Cr McGain requested for an update on the Union's opposition to the University's use of the online proctoring solution ProctorU.

The President stated that discussions with senior administration at UQ were ongoing and the Union was continuing to work on the issue, targeting faculties and course coordinators.

Cr Shihan enquired whether the President knew of course restructures and staff cuts.

The President informed the meeting that apart from the Program Architecture 2 (PA2) project continuing, they were not aware of course restructures and staffing cuts due to the impact of COVID-19.

Cr Pavlou was named once.

# **Student Rights Reports**

Cr Trinh enquired about recruitment and an update on the Academic Advocacy Network (AAN). Cr Plant enquired who the AAN faculty representatives were. As Student Rights VP Fennell was not in attendance, information is pending.

Cr McGain queried the Union's reach out to Swinburne University. VP Pazo said that the Union's Marketing division had been in contact with Swinburne for options on keeping volunteers engaged and implement strategies for Semester 2. In response, VP Pazo said that access to food boxes and bags would be via a registration process through social media channels with the Holt Room as a collection point and that a delivery to the Gatton Campus was being looked at.

Cr Shihan enquired whether the distribution of food survival boxes was enough in the current pandemic situation where University campuses were affected in the first instance with students forced to relocate amidst financial hardship. VP Pazo explained the support was available for students to get through the financial crisis.

#### Secretary's Report

Cr McGain enquired about the COVID-19 Rapid Response Group. Secretary Thornton informed the meeting that the group had had its first weekly meeting the week of 18 May and focused on campus reactivation for Semester 2 depending on the academic landscape. The members were still waiting to hear about University plans for next semester. Secretary Thornton would share more information as it became available.

Campus reactivation was discussed, and the following points were raised:

- Cr Pavlou enquired whether campus reactivation was referring to bringing students back on campus and what that would look like. Cr Shihan enquired about views on campus reopening.
- The Secretary stated that in the interest of student safety, campus reopening would be advised by Government regulations.

#### Treasurer's Report

The following was in response to Cr Shihan request for clarification of the Union's eligibility for JobKeeper:

- Universities are exempt from JobKeeper; however, the Union qualifies being a separate entity.
- JobKeeper pays for qualifying Union employees' positions and that the Union Executive is being paid from JobKeeper.
- No SSAF has been used towards salaries.
- Casual positions in the refrectory: cannot be discussed.

Cr McGain queried the in-principle approval by the Deputy Vice Chancellor (Academic) (DVCA) of the Union's updated budget plans. The President explained that the Union receives a portion of SSAF and raises own revenue from operations, and, as UQU reports to the Student Consultative Group (SCG) an advisory to the DVCA on how SSAF is utilised, the in-principle approval is an accountability measure.

Cr De expressed concerns about future reductions to the SSAF. In response, it was highlighted that the Union had no control of the amount of SSAF as it was collected by the University. An upcoming SSAF review to address increased SSAF allocation to UQU had been delayed due to COVID-19 and more information would be available in June.

A \$34,000 spending in April by Clubs and Societies was queried. This was explained as being most likely from the International Women's Day Breakfast and Market Day and that normal spending did not need approval by the Collective.

#### i) Question Time

#### Question A

Cr De enquired about the University's course restructuring plans and the Unions opposition of the Program Architecture 2 Review and an investigation into course delivery where whole classes were being taught with previous years material and PowerPoints.

Cr Pavlou queried the 30% cut in courses as mentioned in the last UQ Senate meeting. The following points were noted:

- Course restructure was in accordance with Program Architecture 2;
- The President was not privy to Senate documents and not aware of any plans to cut courses on top of PA2;
- UQU runs independent surveys and also with UQ (SSAF Survey, Micro student surveys, etc.). Survey results to be brought to next meeting.

#### **Question B**

Cr Heffernan put forth for discussion, the lowering of costs of degrees. The following responses were noted:

- Ordinary options have not been able to continue due to COVID-19.
- A reach out campaign as highlighted in the Secretary's report would be developed to identify individual issues students are facing. The campaign would be released to students by Semester 2.

#### **Question C**

Cr Heffernan enquired why the PA Review was not addressed prior to COVID-19.

- The President stated that under ordinary circumstances the review would be addressed via Academic Board and the Student Consultative Group.
- Cr Pavlou suggested organising a protest and stated that Academic Board was a rubber stamp body.
- Cr De stated that the PA review be addressed in terms of course cuts, fee increases and staff cuts.

#### Question D

Cr Wang queried whether there was any compensation for international students affected by COVID-19.

• The President responded that they had been in contact with the University re financial assistance to international students and would have more information at the next meeting.

#### **Question E**

Cr McGain raised the issue of the education sector's over dependence on the international student market.

• The education sector has had a long-term international reliance.

- Conversations are being held at senior levels at the University
- The Union has always been concerned on the reliance of international students
- Lower entry levels resulting in massive representation in academic appeals; admissions need to be based on merit and all students extended the same study support.

#### **Question F**

Cr Kugelman queried the decision to hold a Council meeting online and whether the decision to do so was in response to student action. In discussion the following was noted:

- Legal process to suspend standing orders was followed.
- The flying minute was to enable all Councilors to get on board.
- Advice was sought from Mr Peter Travers, the returning officer (and a barrister) employed on a year-to-year basis.

The flying minute circulated 9-11 May 2020 was:

'That Union Council suspend Standing Orders to such extent as is necessary (as determined by the Chair) to facilitate online meetings of Union Council. Union Council grants authority to the Union Secretary and the Chair to organise and facilitate meetings of Union Council via the use of video conferencing technology.'

#### Question G

On request from Cr Shihan, Rizzalli highlighted union activism carried out by the postgraduate portfolio, describing the NTEU fightback against the National Jobs Protection Framework as the most important recent campaign.

#### **Question H**

Higgins enquired about SSAF contributing to Union staffing. It was clarified that SSAF funding is a percentage of Union funding and that the actual amount of Union funding is going to be affected for another couple of years. President Van Roo Douglas had had discussions with the Provost and confirmed that the SSAF pool is not significantly down. Higgins queried whether there was any long-term guarantee for SSAF; The President confirmed that this was dependent on a pending SSAF review.

#### Question I

Cr Kugelman queried the absence of a Semper report. Semper Editor Evans responded:

- That a print edition would be released soon for posterity. The team was channeling focus into pod casts (3 podcasts last week) and online editions (http://www.semperfloreat.com.au/) and had cut budget by 30-40%.
- Upcoming releases would highlight ProctorU and Program Architecture (which was being looked at prior to campus shut down).
- All were invited to contribute to podcasts.

In discussion of the proposal, the following key points were noted:

- A Higher Education sector in crisis.
- UQU opposes University restructures affecting students and staff.
- UQ has huge financial stores and assets.
- Lack of transparency in the measures UQ will undertake to deal with the University's shortfall in revenue.
- Streamlining/retiring 20-30% unviable courses.
- Responses to a Student Action survey indicate previous years lectures are being presented to current students without a reduction in fees.
- UQU to meet with the VC and the meeting be publicised.

- International students stuck overseas still asked to pay full fees.
- Full fee payment is seen as unfair on all students.

#### UQ Union condemns UQ for proposed redevelopment

In discussing the proposal to oppose the University's proposed redevelopment and with reference to Uqs Master Plan, the following was noted:

- UQ's plan for a \$300 million redevelopment of the current student union complex and Schonell Theatre despite community opposition (protests and a petition).
- It was suggested for the monies to be put towards addressing massive cuts due to COVID-19: job cuts and course cuts.
- Media reports (Queensland Times) indicate UQ is reported to have lost almost half a billion dollars in revenue from International student fees.

President Van Roo Douglas reported that all public works including the Union Complex had been put on an indefinite hold.

THAT THE UQ UNION OPPOSES THE DEMOLITION OF THE STUDENT UNION BUILDING, RECOGNISING THAT THIS IS A MAJOR ATTACK ON THE ABILITY OF STUDENT REPRESENTATIVES TO ORGANISE.

THE UQ UNION CONDEMNS THE UNIVERSITY ADMINISTRATION FOR PROCEEDING WITH A \$300 MILLION REDEVELOPMENT IN A TIME OF ECONOMIC CRISIS, AND CALLS FOR THE REDIRECTING OF FUNDS TO:

- SUPPORTING STAFF AND STUDENTS IN THE CURRENT PERIOD AND IN THE FUTURE
- AS WELL AS MAINTAINING THE CURRENT UNION COMPLEX.

#### UQ must refuse to use ProctorU to facilitate exams

- Exam software ProctorU had been contracted to prevent cheating during remote exams.
- UQ did not request for student consent in the use of ProctorU
- ProctorU can remotely access and disable various computer functions.

- Student data can be sold or transferred in case of ProctorU bankruptcy.
- Existing breaches in ProctorU policy re student privacy.
- ProctorU is spyware and invasive.

President Van Roo Douglas informed the meeting that the Union was progressing against ProctorU with written correspondence with the VC and DVCA, with a focus on micro level repercussions. The contract value would be brought to the next meeting.

# Semester 2: reopening in-person campus activities

The following was noted in discussions to consider reopening a viable option at present:

- The motion was to request for an *investigation* into reopening in Semester 2.
- Caution be exercised and any move in favour to be based on medical advice.
- Opposition was expressed to any government or institution putting the economy before students' lives.
- Motion to emphasise only medical advice.
- 2<sup>nd</sup> and 3<sup>rd</sup> waves to be considered.
- Lock downs to remain for as long as possible with advice from the Government and the Chief Medical Officer.
- The motion was seen as pointless as reopening would be on advice from the Government.
