- The fencing of areas in the Great Court for C&S events was queried. It was noted that the fences appeared unwelcoming and that events outside Union Complex had to meet appropriate Public Health Regulations and were required to be fenced.

i. Clubs for ratification

UQ Football Society

Leon Natus presented an overview of the society:

Approximately 40 people responded to a call to play social soccer. The aims of the Society include promoting soccer (socially) and soccer related activities, and promoting fitness within the UQ community. (It was noted that the Backyard Sports Association had similar aims). The organising of social games at UQ was not yet decided and the scale of competition would depend on the membership numbers. Leon stated that the intent of the Society was more social with a *kick it out* outlook.

Name of society: The name was similar to the UQ Sport Football Club. For distinction, a change of name to the UQ Social Football (or Soccer) Society was suggested

University of Queensland Menzies Society

University of Queensland Menzies Society was noted as the new name for the UQ Liberal National Students. The improved aims and objectives of the society were also noted.

Ethan Van Roo Douglas attended on behalf of the Society.

It was noted that:

- The name of the society had changed from a previous Expression of Interest.
- The membership was the same as previously submitted.
- The constitution will be based on the model constitution with the appropriate concessions necessary for a political club.
- This club will have official endorsement from external bodies.
- LNC was not affiliated with the LNP.

Note: At the time of disaffiliation in February, the committee agreed that there was not to be a successor for at least another calendar year.

A short discussion about the funds and donations of the previous LNC was raised; however, it was agreed that this was a separate issue.

i. AGMs/IGMs via Zoom

The option for AGMs and IGMs to be held via Zoom in the current situation was discussed. Moderation of meetings and online RO voting were seen as potential issues. The committee stated that IGMs and AGM's must be recorded and those that are not will be invalid.

iii. Council motion re: C&S Authorising Grant Applications

A motion to distribute C&S grants by membership and not by application was tabled (and was to be referred to this Committee) at the Union Council meeting on 24 August.

Plant, speaking on behalf of a number of clubs who stated that clubs had three avenues of funding: grants, memberships and sponsorships and that grant money added value to memberships and should be distributed based on membership. They said that this year, in Semester 2, no one had received memberships and only \$300 per club.

Further, Plant argued that the regulations state that C&S Committee has authority to grant monies.

In response it was explained that the grant by application supports quality over quantity and that clubs who run no events per year should not receive the same amount as clubs that run over 100 events. It was estimated that between 25%-40% of clubs are currently inactive and as such, should not receive funding as the grants by application is a transparent process.

Wixted said that while Plant many not agree with the process, it is not about what is popular, but rather what benefits the whole of C&S, thus being quality events.

Emily explained that Plant and HMNS would actually benefit from the process, not be disadvantaged.

2020 has proven to be an unusual year; Semester 1 was ok but Semester 2 is not.

Grants applications are approved by C&S department; a process not supported by Plant. Clubs lost money on market day to get more memberships in order to get more grants but grants are only available by application. Plant stated he had no issue of some grant money by application but no one has received money on memberships.

Bartley leaves the meeting.

The motion is scheduled to go back to the next Union Council meeting.
