President Report

Ti Parker praised the Union's support to the Industrial action by NTEU and urged the council members to discuss the ways in which the Union can organize concrete things in support of the strike and, queried the president on updates regarding UQU complex.

President Emily Searle explained on how frequently the proposed plans for UQ Union complex have been changed and how the Union still is making sure Union's best interests are always at the forefront, giving the example of how schonelle theatre has been saved much earlier than expected.

Hughston Parle queried on the emergency accommodation mentioned in her report and upon receiving the explanation of the program, concurred with the president on how the program is much needed and beneficial, considering the international students in need.

Secretary Cara Rowe queried the members of the rules committee on attending the next rules committee meeting and was replied in the negative.

Utkrist Paudyal asked the Secretary regarding two recent events held under the union aegis where bump in and bump out was either not informed or followed. The secretary replied that the motion passed at the council relating to this was communicated to C&S manager as well as the staff member who oversees it and, she would follow it up with them.

Utkrist Paudyal asked UQU GM Glenda Jacobs on the progress in financial arrangement discussions with UQIC and was replied that there has been no further response from UQIC so far.

Hughston parle queried the Secretary Cara Rowe on uploading of the minutes of council meetings online and was informed that she would do it at the earliest.

h) Business which has been proposed

Recognition that Self-Censorship is a problem on campus

Sam Chamberlain spoke on the motion proposed saying there is a responsibility on all of us to fight the conditions that lead to stifling intellectual darkness. He further mentioned that this negatively affects students experiences, and that university should be a place where freedom of expression matters and that UQ administration should be held accountable in that regard. Natasha Brettel spoke on how freedom of expression is essential and that students should be able to express their views freely.

Laura Nolan and Louis McCarthy disagreed with the motion and opined that it was a disguised right-wing agenda to ensure opinions/views suiting the right-wing political leanings can be expressed and urged the council to vote against the motion.

Hughston Parle mentioned that the motion speaks on the need to have a civil discussion and that sentiment should be respected.

To Jacinto Hedu's query on the study that was the basis of the motion and potential bias involved, Sam Chamberlain replied that it was a survey on self-censorship quoted in Australian Financial Review.

Alicia Steele queried on whether the survey had covered the aspects of education being commodified/commercialized and Sam Chamberlain explained on how the sentiments expressed in the survey reflect the fact that self-censorship plays into that.

Ben Myatt opined that proposing a motion based on a study that was not ready by the mover and/or not submitted to the council is not the right way to put a motion to the council.

Utkrist Paudyal left the meeting at 6:45 PM

The UQ Union stands in solidarity with workers across the State of Queensland whose right to join a union of their choice is being curtailed due to the State Government's proposed IR laws. Subsequently, the UQU recognises that having only one choice of union is no choice at all. UQU will publicly condemn the actions of the government on its social media platforms and encourage members to attend future protests relevant to these legislative changes

Samuel Chamberlain spoke on the motion mentioning that there are competitive Unions in Queensland and the current government rules would prevent unregistered unions from representing the rights of workers affiliated with those unions and that we all should stand in solidarity with the workers and support their rights.

Matthew Burgin reserved his right to speak as seconder of the motion.

Laura Nolan spoke against the motion saying it is anti-worker and the Unions this motion is suggesting supporting through, are composed of mostly anti-Vaxxers and urged the council to vote against the motion.

Mitchell Ablett-Nelson disagreed and said that the everyday functioning of such unions is apolitical and centred mostly around protection of and ensuring Workers rights which is why they have been hugely successful in gaining memberships.

Upon a query from Cristian Guitierrez on whether existing unions cannot be improved upon or integrated into rather than form a new union, Sam Chamberlain explained how competitive Unions are good and benefits the workers overall.

There was a procedural motion that the motion be put

Matthew Burgin as the seconder of the motion spoke on how competing unions benefits the workers especially when inflation is rising, competitive unions lead to reduced membership prices and the potential conflict of interest for Queensland govt in formulating this law.

THAT THE UQ UNION STANDS IN SOLIDARITY WITH WORKERS ACROSS THE STATE OF QUEENSLAND WHOSE RIGHT TO JOIN A UNION OF THEIR CHOICE IS BEING CURTAILED DUE TO THE STATE GOVERNMENT'S PROPOSED IR LAWS. SUBSEQUENTLY, THE UQU RECOGNISES THAT HAVING ONLY ONE CHOICE OF UNION IS NO CHOICE AT ALL. UQU WILL PUBLICLY CONDEMN THE ACTIONS OF THE GOVERNMENT ON ITS SOCIAL MEDIA PLATFORMS AND ENCOURAGE MEMBERS TO ATTEND FUTURE PROTESTS RELEVANT TO THESE LEGISLATIVE CHANGES.

UQU Supports NSW Public Sector Strikes

Will spoke on the motion proposed saying it is a horrible nightmare the current wages that are being rolled out, the Union and the council should care more about supporting the unions in NSW and that this should be the start of a fightback.

Ti Parker mentioned that this is the right way to rebuild Unions. She further mentioned that workers across Australia should take inspiration from the strikes in NSW, challenge Union bureaucrats, defy the Union leaders when offered a bad deal and fight to make sure workers see a way out of this crisis.

Mitchell Ablett-Nelson disagreed with the motion saying that a way needs to be found to blend the impact of low income and inflation rather than ending up in a 1970s era spiral of economy and that long term strategic healthy economy recovery should be prioritized over Short-term comfort into the end of a decade.

Hughston Parle spoke in favour of the motion saying public sector workers are currently struggling and they need our support.

Various members spoke and disagreed on the ways to bring inflation down.

UQU stands in solidarity with staff and actively supports the 24-hour NTEU Strike taking place on September 1st

Laura Nolan spoke on why the strikes are necessary and the importance of ensuring wages rise enough to stay above inflation levels. She deplored the university not meeting the demands of the workers when executives are being paid ridiculous high wages, has ties to climate criminals and businesses. She further mentioned that the members show and active interest in participation and that the Union should show solidarity with the strike, urged the student executives to attend the strike and to encourage the wider student body to do the same.

Jack mentioned that the proposed actions and activities are in the Union's best interests and opined it would be more productive if the Union can discuss further on Student Engagement with regards to this.

President Emily Searle informed the members of the Council that the union would be promoting the strike as well as any future actions after that. She mentioned to the members that she had a discussion with NTEU Brisbane Chapter and that UQU stands firmly behind NTEU on this. She clarified to Barclay McGain that Students will be informed on why the strike is being proposed and it is up to the discretion of the students on whether to attend the strike or not.

Jacinto Hedus disagreed with the views of Barclay McGain on students missing classes for a day and, opined that staff not getting paid adequately and poorly looked after by the administration leads to sub-par quality of education delivered to students and if by missing classes for a day, students can highlight and champion the cause of the staff, then it is worth doing so.

UQU condemns the refusal of Labour Government to raise the age of Criminal Responsibility

Will Sim spoke on how the refusal of QLD govt to raise the age of Criminal Responsibility is horrible and racist, and that the UQ union should vociferously demand that the QLD labour party take responsible action that benefits the indigenous people, who are the most affected by such racist policies.

Ella Gutteridge spoke on how this is an abhorrent racist policy and explained to the members of the council of the current situation in northern Territory as an example and how this act by Qld government is nothing but state sanctioned racism and can potentially create new stolen generation.

Secretary Cara Rowe agreed with the motion and urged everyone to vote in support of this motion.

Mitchell Ablett-Nelson mentioned that while is he is clearly not in favour of incarcerating young children, he does not believe raising the age of criminal responsibility is the answer to that and that there is a genuine purpose in society placing an offending person in prison.

Upon a query from an observer on the constitution of Union allowing social issues to be raised at council, Secretary Cara Rowe informed the Council that, if a student has a belief and wants to make a representation to the council on behalf of students, pertaining to a social issue, they can and will be allowed.

Samuel Chamberlain and Barclay McGain left the meeting at 7:59 PM.

UQU condemns Labour's Greenwashing Climate Bill

Asha Coles spoke on how the Climate bill by labour government is deficient on enforcement and the reduction targets are already tiny while excluding the exports ignoring the fact that emissions are more from exports too. She mentioned that students should have a liveable future and as a union UQU should support the role of students in fighting for climate action.

Louisa McCarthy spoke on how this bill is not better than nothing but in fact is nothing. The mentioned targets will not be met anyway, and the approved gas projects alone will mean that the targets are in achievable, even in their deficient form.

Gabby Callow spoke in support of the motion but clarified to the members of council on the emissions from exports and clarifying the nature of coal exported by Australia and the nature of emissions and energy created by such coal. Mitchell Ablett-Nelson expanded on the views expressed by Gabby Callow and explained further on how the distinction is important.

Ti parker disagreed saying that it is a cynical argument and that the differentiation between coal types does not take away the fact that it is still a fossil fuel at the end of the day.

President Emily Searle spoke on how the union should oppose the lack of student representation on important committees such as Student Infrastructure Committee, Senate Diversity Committee etc. She highlighted the fact that University Administration can simply handpick members of committees otherwise. She commended the UQ Ally Action Committee for having representation from queer collective.

The minutes reflect that Student Action opposed election of elected student representatives to university bodies.
