Getting Started Program To Include Work Rights

Cr Pereira explained that International Students are not aware of their work rights in Australia and are often exploited in employment. They suggested the inclusion of information about work rights in Australia in the UQ run Getting Started Program for International Students to ensure awareness and information on who to approach to lodge complaints.

Cr De stated that laws make International Students vulnerable, the bigger problem is misinformation and encouraged all students to join trade unions.

Cr Shihan highlighted that there is a separation between international and domestic workers with restrictions. Where exploitation happens, workers put up with it or risk losing their visa. solidarity is needed across both sectors of the workforce.

UQ Union Endorses the Climate Strike on Friday 25 September 2020

Gutteridge and Bradshaw explained that it was essential for endorsement of upcoming climate actions and that students care about the process and proved it in 2019 where school strikes in Australia were proportionately the largest in the world with around 40,000 participating in Brisbane.

They drew attention to the wildfires currently ravaging California; the most ferocious and far reaching that the state has ever recorded in history. Images mirror those of the bushfires in Australia during the 2019-2020 bushfire season.

They also stated that world leaders had failed to make significant changes to halt the effects of climate change and address global warming issues. In response, students and young people worldwide have organised strikes for the climate.

In discussions the following was highlighted:

- Lack of Government preparation for the upcoming bushfire season.
- Increased funding for fire-fighting services required.
- Bushfire smoke could increase the spread of COVID-19 this summer.
- Natural disasters were increasing in frequency because of global warming.
- Scientists have declared a state of climate emergency with increasing temperatures and rising sea levels which would see this affecting the Asia-Pacific region earlier.
- Students care about the climate process.
- Cr McGain stated that California also had the largest amount of renewable energy supplies and that water security and scarcity needed to be addressed.
- America is not taking any action to address global warming.

THE UQ UNION RECOGNISES THE URGENT NEED TO PROTEST FOR CLIMATE ACTION AND STAND IN SOLIDARITY WITH STUDENTS DOING SO INTERNATIONALLY.

THE UQ UNION RECOGNISES ACTION ON THE CLIMATE IS URGENT, THAT MASS PROTESTS ARE AN ESSENTIAL WAY OF STRUGGLING FOR CLIMATE JUSTICE, COMPLICITY OF THE GOVERNMENT IN DESTROYING THE CLIMATE AND ENDANGERING LIVES OF MILLIONS OF ORDINARY PEOPLE.

THE UQ UNION DEMANDS THE GOVERNMENT TO PREPARE FOR FIRE SEASON BY FUNDING FIREFIGHTERS, REMOVING SUBSIDIES FOR FOSSIL FUEL COMPANIES AND CEASING ALL MINE AND GAS MINING.

THE UNION DEMANDS THAT THE UNIVERSITY DIVESTS FROM FOSSIL FUEL AND CUTS TIES WITH THE INDUSTRY.

Justice for Aunty Sherry

Aunty Sherry Fisher-Tilberoo died on 10 September 2020 while in custody in a Brisbane watch house while awaiting transfer to a correctional facility.

Cr Shihan spoke out against police racism and negligence and related deaths in custody.

Higgins stated that Aunty Sherry's case indicates that racism and deaths in custody are not confined to towns and no one should be happy that people are dying in prison cells; they said that this would be a great opportunity for all people to take a stand.

Cr McGain said that we should stand against all police brutality.

In discussions, the following views were expressed:

- Queensland Police condemned for racist policing.
- 441 indigenous people have died in custody since the Royal Commission into Indigenous Deaths in Custody.
- Aunty Sherry was not connected to any crime.
- It is the ignoring of the needs of indigenous people that leads to deaths.
- 100% of youth detained in NT are indigenous.
- The only reason the police officer was suspended was because of the protests.
- Indigenous people make up 3% of the population and they are targeted.

THAT THE UQ UNION STANDS IN SOLIDARITY WITH THE FISHER-TILLBEROO FAMILIES AS THEY DEMAND JUSTICE FOR AUNTY SHERRY.

THE UQ UNION CONDEMNS THE QUEENSLAND POLICE FORCE FOR THEIR RACIST POLICING.

THE UQ UNION STANDS IN SOLIDARITY WITH THE NATIONAL CAMPAIGN TO END BLACK DEATHS IN CUSTODY.

THE UQ UNION RECOGNISES THAT ANY JUSTICE FOR BLACK LIVES NEEDS TO BE FOUGHT FOR AND CALLS ON STUDENTS TO ATTEND ANY FURTHER PROTESTS THAT ARE HELD DEMANDING JUSTICE FOR AUNTY SHERRY.

UQ Union supports the right to protest and stands with the campaign in NSW

Cr Heffernan expressed agreement with reasonable quarantine measures but not total hypocrisy as is happening in NSW and the indefinite unjustifiable ban of protests under NSW health orders. In discussion, the following was raised:

- NSW is pressuring VIC and other states to open borders
- NSW has a stadium to open (whereby 10,000 are permitted to attend NRL matches)
- No cases of COVID have been linked to protests but links to stadiums, universities and other areas have been confirmed, indicating the ban on protests is not about reasonable measures but political issues around Australia.
- These measures are continuing to spread across Australia.
- People are being denied the right to mourn; this is a motion re: civil liberties.
- The government is allowing casinos, etc. without masks but restricting protests and using COVID restrictions to break up protests.
- UQU should stand in solidarity with this campaign.

THAT THE UQ UNION STANDS IN SOLIDARITY WITH THE DEMOCRACY IS ESSENTIAL CAMPAIGN IN NSW, FIGHTING FOR THE RIGHT TO PROTEST WITHOUT STATE REPRESSION. THE UQ UNION WILL NOT STAND BY AND LET THE RIGHT TO PROTEST BE TAKEN AWAY FROM STUDENT ACTIVISTS. THE UQ UNION DEMANDS THAT PROTESTS BE DEEMED AN ESSENTIAL ACTIVITY AND RECOGNISE THAT THE GOVERNMENT CANNOT USE THE PANDEMIC TO STIFLE THE RIGHT TO PROTEST SAFELY AND PEACEFULLY.
