Karsten Duvel queried the Environmental officers on the pragmatic actions undertaken by the environmental officers as part of their portfolio and raised the absence of activities from the collective such as clean-ups etc. the Environmental officers replied that most activities are centered around creating awareness, providing educational opportunities to the students and encouraging the students in getting involved in environmental activism and work towards environmental actions. They further clarified that the funding of the collective goes towards educational awareness and outreach.

Matthew Pereira queried the International officer Rita Zhou on the exclusion of international student demographics aside from china from the welcome pack distribution. Rita clarified that it was on account of Chinese students missing out on the 0-week because of travel restrictions in their country and not in anyway catering to one demographics alone. In response to another query regarding the usage of social media to inform international students, Rita replied that focus on wechat is because of accessibility issues for students in china but agreed to have it across the board in future.

Regulation Changes:

The Secretary informed the council members on the regulation changes being proposed, the motions related to them and that they were recommended by the last rules committee meeting.

Entitlements for Disability Officers and International Officers

Disability Officer Sian Chadfield spoke on the advocacy needed through the disability collective considering the various needs of the disabled students and issued faced by them. They further spoke on how accessibility issues and information is a huge problem and with significant number of University schools and officials looking to engage with the disability collective for research and understanding, the collective and the officers are undertaking a lot of work.

Matthew Pereira endorsing the views expressed by the disability officer, proposed an amendment to the motion that the paid working hours of the disability officers be raised to the same level as the VPs, to 76 hours per fortnight. He further mentioned that the disability officers and the international officers undertake a significant amount of work and it is only fair that they are paid for the same.

Max Thomson mentioned that the budget for the year was already formulated and passed and feels that the current wage increases are enough and that it matches what is expected of the roles as outlined in previous meetings and discussions.

Alex Mcdowall spoke on the effects of increased indexation of HECS on the student population and the increase in line with inflation is a crippling burden on the students.

Ella Gutteridge waived her speaking rights to Kore Opie.

Kore mentioned that students on Youth Allowance spend over 70% of their allowance on rent alone and that the Union should fight for the students and condemn such actions by the government.

UQU condemns the Qld government and the police for the widespread sexist and racist policies

Asha Coles spoke on the proposed motion highlighting the violent behaviour, sexism and racism prevalent in the QLD police services and how the accused officers are being reinstated and there is an utter lack of accountability within the department. She urged the members to oppose the opening of the new youth bail laws, detention centres and bloated budgets for the department.

Will Sim spoke on how when atrocities committed by the police officials are being highlighted, QLD premier has praised the police services in a recent speech. He urged the council and the Union to condemn the QPS and to take a firm stand on these issues.

Ryley Calvert spoke in favour of the motion mentioning the tragic personal incident in his life where he lost a cousin due to the actions of QPS in the year 2018 and the coroner's report was handed in only this year, leading to a traumatic wait of 5 years for the family awaiting justice.

Matthew Pereira mentioned that he supports condemning the QPS but not the revoking of youth bail laws and support for defunding the police. He highlighted the resulting impacts of youth crime on people and why he is taking a stance against supporting the revoke of the bail laws.

Priya De mentioned the various motions put forward across the years at the Council on police brutality, and urged members to speak out against the party as being members of the party does not mean they cannot speak against the labour government and that as a student Union, the members should collectively challenge the government together

UQU supports the Uluru Statement

President Richard Lee mentioned that the proposed motion has the endorsement of the Goorie Berrimpa officers, highlighting that UQ is the only university not to have come out in support of the voice which is disgraceful on part of the University considering the reconciliation action working group of the University has already written a letter in support of the voice. He further mentioned that it is an important stance for the Student Union to have and urged everyone to stand on the right side of history.

Jeryn Chang waived her speaking rights.

Will Sim urged the members to not support the motion unequivocally and mentioned that there is no consensus amongst the indigenous community on the Uluru statement and also that the voice will not change the discriminatory policies of the labour government.

Max Thomson spoke against the motion mentioning that in his experiences with his godfather and conversations with his daughter, he understood the context better and is expressing his opposition to the voice. He further mentioned that the voices championing the Voice do not reflect the reality of issues and understanding of the indigenous people.

Elise Northcote mentioned that any referendum even seen as a symbolic one should still be seen as powerful in the symbolic value it represents.

Union council recognises that the Union bodies should be politically neutral

Matthew Pereira spoke on the proposed motion saying that when the Union bodies post on social media accounts, it must be ensured that they cannot take political stance/sides without the consent of the council. He further spoke on the second motion concerning meetings saying that meetings like the rules committee should be held after working hours as it would it make it easier for the students to participate. He also spoke on the third proposed motion relating to the labour government decision to allow entry of temporary visa holders which led to a huge increase in rental prices and urged caution about such steps in future.

Ti Parker condemned the proposed motion directing the Union bodies to be politically neutral saying that it is nothing but curbing free speech and that the collectives and the elected student officers should be able to take a stance on issues.

Utkrist Paudyal mentioned that when it comes to rules committee meetings, members did not offer their availabilities despite the repeated requests from the Secretary.

There was a procedural motion that the three motions be put to vote en bloc except for the motion proposing one minute silence for Anzac Day.
